In case they are not found fit, their candidature will not be considered. Concerned Zonal Railway will take an undertaking to undergo medical re-examination from the candidates. The medical re-examination and further process in this regard will be carried out by the concerned Zonal Railway as per extant procedure.
- 3.0** Candidature of all the candidates appearing in this panel is purely provisional and is liable to be cancelled in case any inconsistency/ deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB/ Zonal Railway at any stage of the recruitment/ appointment process. It may be noted that merely getting placed in the provisional panel does not entitle him/ her in any way to an appointment in the Railways.
- 4.0** All pre-appointment formalities like verification of educational qualification, caste certificates and other relevant documents is to be completed before offering the appointment letter to the candidates as stated in Railway Board's letter.
