## Empanelment of $\mathbf{3 0 \%}$ waitlisted candidates for the post of Assistant Loco Pilot, Cat. No. 01 of CEN:01/2011.

1.0 Following candidates of Railway Recruitment Board/Malda of CEN:01/2011, have been placed in the list of $30 \%$ excess (waitlisted) candidates for the post of Assistant Loco Pilot, Cat. No.01.
